 - Stewart & Stevenson had to be called out again for regen / programing issues. Still no word on a better fix for this issue, was told to expect it to come up more often with cooler weather. (so far, its covered under warranty)

 - Had a complaint from the academy that the unit will not build air in the storage tanks. Had it brought to the shop to troubleshoot. Isolated the compressor and tested its ability to build air, had no issues. Found that the storage tanks were down to 2000PSI, opened up the valve to manually fill storage from compressor and run unit. Unit ran for an hour to recharge the storage. Tested system for leaks and filled a couple bottles. Im thinking a valve was left closed or possibly got some frost?

 - Air psi gauges in the dash cluster would stop working at random times, had to replace the cluster module, special order from the factory.

 - Check engine light states there is an issue with the pressure differential in the EGR system. Clean out ports, and sensor, and retested. No further issues. Soot from reburning exhaust gasses will eventually plug up small ports and sensors.
 - o Replaced a broken pump panel gauge
 - Command light has issues in auto park, had to re-align and adjust position sensors.
 - Foam system is not working, noticed that it isn't showing any flow. Tested paddle wheel and found it to be faulty. Installed a new paddle wheel and tested operation.
 - Dipstick tube had cracked from age and heat, causing an oil leak. Temp, patched it up, was unsure we could get one.
 Spartan said it was discontinued... after arguing and waiting for 4 months we finally received one to replace it.
 - Complaint that the rear intake valve will not work, removed the pump panel to test. Electric motor works fine, switch is fine, found that the valve is stuck due to lack of being used/ exercised. Freed up valve and operated to test.

 - Gen would not start, tested system for fuel and voltage, also had NO faults. Called in Honnan Equip. to hook up to their computer. Tech stated that old fuel will plug the injectors and cause a no start problem. Had all injectors replaces, all old fuel pumped out and fresh put in. We will now have a longer, more often run/ test time for this generator.

 - o Heater in bedrooms repaired, inducer motor was bad.
- Station 54
 - Damper door in heater vent for community room stays shut, causing a fault in the heater. Repaired damper door

- •Annual aerial and ground ladder testing were completed.
- •Had 3 ground ladders that needed repaired. (done) 2 roof ladders had to be replaced (ordered)
- •Tower 51 had a weld cracked on the top rail of the base section. It has been repaired and retested and back in service. Can't explain why this crack happened.
- •Trk 52 had cracks in the waterway(pinable bracket) next to the nozzle, removed the bracket and welded. Retested and placed back in service. The ladder cradle was also cracked.

Office of Emergency Management

City of Brighton Emergency Declaration- Still in effect. City Council voted to extend the emergency declaration indefinitely to continue to address COVID-19 related needs and expenses.

On Oct. 20th, City Council decided to opt back into the TCHD maks order which will extend through the duration of the pandemic.

City of Brighton EOC Coordination- Due to the severe increase in the number of cases both in the City of Brighton and Adams County, the EOC coordination meetings are continuing on a weekly basis.

City Hall remains closed to the public and essential meetings are by appointment only. City Council meetings have moved to all virtual for the foreseeable future.

Interim COIVD-19 Response AAR/IP- survey for staff closed on November 4th. Contractor will be presenting initial findings on Nov 18th in advance of submitting a draft AAR/IP for review

OEM Assisted Larimer County EOC in remote activation as PLans Section to support Cameron Peak and E. Troublesome Fire response, 10/24 & 10/25.

Adams County Hazard Mitigation Plan- completed and is ready for municipal approval.

Emergency Shelter Plan- 2020 updates completed and pandemic considerations fully integrated

EOC Activation Plan- revising to reflect needs for social distancing while maintaining operational readiness.

Community Testing- City of Brighton sponsored testing continuing at Adams County Regional Park t(relocated from EVAC) through at least November 21st. Additional testing options to be explored after first allocation of funding has been expended.
